The MS Society has teamed up with two Will-writing services to help make writing or updating a Will as easy as possible for our supporters.

The Goodwill Partnership takes the hassle out of writing a Will, by arranging for an appointment for you to get a solicitor-written Will from the comfort of your own home. While our membership of the National Free Wills Network means you can make or update your Will free of charge.

Both of these services are trusted and reputable, and have helped thousands of people in the UK write or update their Wills. So you know you'll be in safe hands.



The MS Society is a member of the National Free Wills Network. This means that, as an MS Society supporter, you can enjoy access to a solicitor who can make or update your Will for free.

There is no obligation to include a gift to the MS Society if you decide to use this service, although we hope this is something you would be willing to consider.

If you decide to take advantage of this offer, the first step is to let us know that you would like to use the service. We will then pass your details on to the Network safely and securely, and they will send you an information pack that contains a list of solicitors in your local area and a Confidential Declaration Form.

When you receive your pack, all you have to do is to choose a solicitor from the list – which will most likely be the one nearest to you. When you visit the solicitor, they will then help you write or update your Will without you having to worry about the cost.

The Goodwill Partnership is the largest distributor of home-visit solicitor-provided Wills in England and Wales. The MS Society has teamed up with these experts to help make the process of writing or updating a Will as simple as possible for our supporters.

We understand leaving the house to visit a solicitor isn't an option for all of our supporters – especially those who are living with MS. But when you use The Goodwill Partnership to make your Will, there's no need to visit a solicitor's office. Instead, the Partnership will arrange for a trained local counsellor to come to your home at a time that suits you – daytime, evenings, or even weekends.

The counsellor who comes to you will listen carefully to what you want from your Will. They'll then pass on your instructions to a panel of specialist solicitors who can also provide legal advice and storage of your signed Will. In the unlikely event of any complication, a solicitor will call you directly.

The Goodwill Partnership guarantees the lowest price for a home-visit Will in England and Wales. They charge one low, fixed price – no matter how detailed your Will – and the counsellor visit is provided free of charge. They also provide a discount on a second Will for your spouse or partner.
