Why wills matter

Whatever your circumstances, it's important to have a legally recognised and up to date will. It's the best way to leave a true record of your wishes and make sure the people and causes you care about benefit from what you leave behind.

Of course, if you're thinking about writing or rewriting your will, we understand it's only right that your loved ones come first. But any amount you do decide to leave to the MS Society, no matter how big or small, will make a huge difference to the future for people with MS.

Gifts in wills are something special. Whatever its size, yours will help transform the lives of so many people in the future. It could be you that offers someone the information and support they need to live their best life. It could be your gift that leads directly to developing an effective new treatment. Or you could be the one helping speed up discoveries, by making more studies and research possible, to stop MS.

“When I think we could one day stop MS, I think about waking up refreshed. Going a whole day without pain or fatigue.”

Bella was diagnosed with MS when she was 15 years old. She lives with her husband, and says the most important things helping her to live well with MS are diet, exercise, and laughter. She hopes to keep living her life to the fullest in future – and that’s something a gift in your will can support her to do.

“It means a lot to me that people support the MS Society by leaving a gift in their will. It’s a charity that does so much for those of us living with MS.”

Bella hopes these generous gifts will help fund the research that finally puts a stop to MS. She also wants to make sure people in her position continue to have someone to talk to and access to the information they need to fully understand their diagnosis.

How to get started

Whether you’re writing a new will or updating an existing one, we strongly recommend you work with a solicitor or professional will writer. They’ll know how to make sure your wishes are expressed in the right way and remove unnecessary stress for you and your family.

It may seem daunting, but getting your will written is relatively straightforward. Your will writer will take you through all the steps and make sure your wishes are outlined in full.

Before you meet with them, there are a few things you might want to think about. This can save you time and money when preparing your will. You should:

- **Make a list of assets and estimate their value.** We’ve enclosed a checklist that can help you work this out.
- **Make a list of what you owe or are owed.** This might also be referred to as your ‘liabilities’ list by a solicitor.
- **Decide who you’d like to benefit from your will, and choose your executor.** Your executor will take legal responsibility for carrying out the instructions in your will.

The difference your gift could make

In recent years, MS research has made huge leaps forward – and we simply can't afford to stop now. There are convincing and promising signs for the future, but we can only reach our goal to stop MS with your support.

We've come so far in the last 20 years:

- ▶ **We've gone from just 3 disease modifying therapies (DMTs) to 19**
- ▶ **Increased our knowledge by discovering over 200 genes linked to MS**
- ▶ **Developed new symptom management treatments**
- ▶ **Discovered treatments, now licensed, for both primary and secondary progressive MS**

As inspiring as the last 20 years have been, there is still so much work to be done. We're funding ways to speed up the development of treatments. And with every new breakthrough, we get closer to the day we'll stop MS.

With new knowledge being gained on how to repair myelin and protect nerves, new projects funded and clinical trials underway, there's real momentum and hope on the horizon – a gift in your will could help us finish the work we've started, together.

Choosing a gift that works for you

If you'd like to remember the MS Society in your will, there are four different types of gift you can include.

Residuary gift

A gift made from the remainder of your estate after expenses like debts, liabilities and inheritance tax have been taken care of and any specified gifts have been made. You can decide to give a percentage of what remains, or all of it.

Pecuniary gift

Also known as a cash gift, where you decide on the specific amount for the gift.

Specific gift

This means a particular item, such as a house, jewellery, stocks and shares, or the proceeds of a life insurance policy.

A conditional gift

This is a clause included in your will to cover unforeseen circumstances. For example, if the person you intend to leave your estate to dies before you.

How to word your gift

If you decide to include a gift to the MS Society in your will, please ask your solicitor to use the following wording:

Residuary gift

"I leave x% of the residue of my estate to the Multiple Sclerosis Society, 8 City North Place, London, N4 3FU, registered charity number 1139257 (SC041990 for Scotland) for its general charitable purposes absolutely."

Cash gift

"I leave the sum of £x to the Multiple Sclerosis Society, 8 City North Place, London, N4 3FU, registered charity number 1139257 (SC041990 for Scotland) for its general charitable purposes absolutely."

You can also leave your gift to a particular area of our work. If you contact us first, we can talk you through how best to word your gift to make sure your wishes are delivered.

Please note that the suggested wording above is not intended to constitute legal advice. For all matters relating to the wording of clauses in your will, please speak to your solicitor or will maker.

Heather was diagnosed with relapsing MS in 2014. She lives with her partner, Sid, and her dog, Willow. Heather told us that her key to living well with MS is prioritising her mental and physical health – through yoga, horse riding, and taking Willow on walks. Your will writing questions answered

Can I write my own will?

‘DIY’ wills are easy to get wrong. So we would always recommend getting yours made through a solicitor or qualified will writer, to make sure everything is legally right. You can find a local solicitor by using the search function on the Law Society’s website. If you’re concerned about fees, we offer our supporters free access to a solicitor, home visits, and will writing services online or by telephone. We’ve included details of these alongside this guide.

Could making a gift reduce my inheritance tax liability?

Yes (at the time of writing). If your estate is above the Inheritance Tax (IHT) threshold, and you leave at least 10% of the taxable proportion of your estate to a charity, this will reduce your overall IHT liability from 40% to 36%. Also, any gift left to charity in a will is received free of IHT. We recommend you discuss all matters relating to IHT with your solicitor or will maker.

Should I inform you that I’ve included the MS Society in my will?

It’s entirely up to you. This is a very personal decision you’ve made, but it’s lovely for us to be able to reach out and offer you our thanks, as well as keep you updated about our work.

Can I donate my body to medical research for MS?

Yes. You can donate your brain and spinal cord to **The MS Society Tissue Bank**. It’s a vital resource, with donated tissue helping scientists around the world to advance our understanding of MS. To find out more or register as a donor, please visit: mssociety.org.uk/tissuebank
